3. Public Comments – Comments from the public on non-agenda items. Public comments are limited to two minutes per speaker.
4. Discussion and Possible Action regarding creating a Holiday ornament-making event to be held in December at a local venue. Children will be invited to come and make a holiday ornament in a festive setting. Funding will be requested in the range of \$500.

If a motion for reconsideration is not made on the date the action was taken, then a Board member on the prevailing side of the action must submit a memorandum to the Secretary identifying the matter to be reconsidered and a brief description of the reason(s) for requesting reconsideration at the next regular meeting. The aforesaid shall all be in compliance with the Brown Act.

Comments from the public on Agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the Agenda that is within the committee's subject matter jurisdiction will be heard during the Public Comment period. Public comment is limited to 2 minutes per speaker and for a maximum of 20 minutes, unless waived by the presiding officer of the board.
