3. Public Comments – Comments from the public on non-agenda items. Public comments are limited to two minutes per speaker.
4. Discussion and possible action to approve outstanding minutes from prior Executive Committee meetings.
5. Discussion and possible action regarding making an amendment to an already adopted motion. The General Board approved a motion at the September GB meeting to cosponsor a movie night with LAPD, however the date in the approved motion has since been changed from 10/3/15 to 10/10/15.
6. Discussion and possible action regarding upgrading the size of the Public Storage Unit currently being used by LA32NC to store equipment. The change will result in a monthly fee increase of approximately \$100.00
7. Discussion and possible action regarding the creation of the agenda for the October 7, 2015, General Board meeting. The Executive Committee will discuss and create the items that will be listed for the board's October 7, 2015 meeting.
8. Adjourn

The Board may reconsider and amend its action on items listed on the agenda if that reconsideration takes place immediately following the original action or at the next regular meeting. The Board, on either of these two occasions, shall: (1) Make a Motion for Reconsideration and, if approved, (2) hear the matter and take action. If the motion to reconsider and action is to be scheduled at the next regular meeting following the original action, then two items shall be placed on the agenda for that meeting: (1) a Motion for Reconsideration on the described matter and (2) a Proposed Action should the motion to reconsider be approved. A motion for reconsideration can only be made by a Board member who has previously voted on the prevailing side of the original action taken. If a motion for reconsideration is not made on the date the action was taken, then a Board member on the prevailing side of the action must submit a memorandum to the Secretary identifying the matter to be reconsidered and a brief description of the reason(s) for requesting reconsideration at the next regular meeting. The aforesaid shall all be in compliance with the Brown Act.

Comments from the public on Agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the Agenda that is within the committee's subject matter jurisdiction will be heard during the Public Comment period. Public comment is limited to 2 minutes per speaker and for a maximum of 20 minutes, unless waived by the presiding officer of the board.
