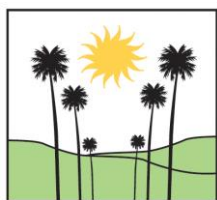

 - b) Up2Us Sports is planning a day of play in collaboration with Wilson High School on Friday March 31st. UP2Us would like to Collaborate on this event and connect with the Neighborhood Council. They plan to open this event up to the community where 90-100 coaches are providing free sports/physical activity programming at Wilson on Friday to at least 200 youth from the community.
 - c) From Arroyo PlayGround- Request Considering LA-32 NC's support for the El Sereno Arroyo Playground Honor Your Park Day on March 18th. What the Vecinos are seeking is sponsorship for food, and perhaps, some giveaways for the kids. We are asking for \$400.00 for food, and if LA-32 is interested in providing giveaways for the kids, they could give them out at the event. If we have confirmation of LA-32's support by Thursday, March 2nd, we can include the LA-32 logo in our outreach materials. Regardless, LA-32 is welcome to set up a canopy at the event to provide outreach to the community. The Vecinos are having a planning meeting on **March 8th at El Sereno Graphics on Alhambra Ave, from 6:30 pm - 7:30 pm**, We are hoping you or a representative from the board can attend. LA-32 has been a valued supporter of the El Sereno Arroyo Playground since before it was built, and sponsored our first BBQ when we announced to the community that we were getting the park. **(I will attend this meeting)** and then report to Sports Committee 3/9

The Board may reconsider and amend its action on items listed on the agenda if that reconsideration takes place immediately following the original action or at the next regular meeting. A motion for reconsideration can only be made by a Board member who has previously voted on the prevailing side of the original action taken. If a motion for reconsideration is not made on the date the action was taken, then a Board member on the prevailing side of the action must submit a memorandum to the Secretary identifying the matter to be reconsidered and a brief description of the reason(s) for requesting reconsideration at the next regular meeting. The aforesaid shall all be in compliance with the Brown Act.

Comments from the public on Agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the Agenda that is within the committee's subject matter jurisdiction will be heard during the Public Comment period. Public comment is limited to 2 minutes per speaker and for a maximum of 20 minutes, unless waived by the presiding officer of the board.
